Step 4: Made a searching and fearless moral inventory of ourselves.

Made a searching and fearless moral inventory of ourselves.

Step Four is the vigorous and painstaking effort to discover what the liabilities in each of us have been, and are. I want to find exactly how, when, and where my natural desires have warped me. I wish to look squarely at the unhappiness this has caused others and myself. By discovering what my emotional deformities are, I can move toward their correction. Without a willing and persistent effort to do this, there can be little sobriety or contentment for me.

To resolve ambivalent feelings, I need to feel a strong and helpful sense of myself. Such an awareness doesn't happen overnight, and no one's self-awareness is permanent. Everyone has the capacity for growth, and for self-awareness, through an honest en-

Tradition 4: Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

The Fourth Tradition long form:

With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.

It states in the book "AA Comes of Age" that "the Traditions ask that every individual and every group and every Area in A.A. shall lay aside all desires, ambitions, and untoward actions that could bring serious division among us or lose for us the confidence of the world at large." (page 96-97). The membership of Alcoholics Anonymous is referred to in the text of Tradition Four in the 12 and 12 as "largely a

counter with reality. When I avoid issues but meet them directly, always trying to resolve them, they become fewer and fewer.

We finally saw that the inventory should be ours, not the other man's. So we admitted our wrongs honestly and become willing to set these matters straight.

Why is it that the alcoholic is so unwilling to accept responsibility? I used to drink because of the things that other people did to me. Once I came to A.A. I was told to look at where I had been wrong. What did I have to do with all these different matters? When I simply accepted that I had a part in them, I was able to put it on paper and see it for what it was—humanness. I am not expected to be perfect! I have made errors before and I will make them again. To be honest about them allows me to accept them—and myself—and those with whom I had the differences;

from there, recovery is just a short distance ahead.

We were having trouble with personal relationships, we couldn't control our emotional natures, we were a prey to misery and depression, we couldn't make a living, we had a feeling of uselessness, we were full of fear, we were unhappy, we couldn't seem to be of real help to other people.

These words remind me that I have more problems than alcohol, that alcohol is only a symptom of a more pervasive disease. When I stopped drinking I began a lifetime process of recovery from unruly emotions, painful relationships, and unmanageable situations. This process is too much for most of us without help from a Higher Power and our friends in the Fellowship. When I began working the Steps of the A.A. program,

band of ego-driven individualists. Children of chaos, we have definitely played with every brand of fire, only to emerge unharmed and, we think wiser." So, as for the question of whether or not the freedom that group autonomy gives us is dangerous, the answer appears to be no, provided we work within the intent and spirit of Tradition Four.

Let us look at Bill W's own experience with "group will." "As one of the people who helped start this movement, I thought for a long time that I ought to be able to manage it from New York. But I soon found that I could do no such thing. Neither could anybody else at A.A.'s headquarters. The groups said to us, "we like what you are doing. Sometimes your suggestions and advice are good. But whether to take you or leave you alone is going to be our decision. Out in the groups, we are going to run our own show. We

are not going to have a personal government in New York, or anywhere else. Services yes. But government, no." Hence, A.A.'s Tradition of group autonomy. They told us what they wanted and that included the right to be wrong." (A.A. Comes of Age, page 103). And out of A.A.'s experience with group autonomy came our beloved rule #62.

"Don't take yourself too damn seriously

Autonomy is a ten-dollar word. But in relation to us, it means very simply that every A.A. group can manage its affairs exactly as it pleases, except when A.A. as a whole is threatened. Over the years, every conceivable deviation from our Twelve Steps and Twelve Traditions has been tried. These very deviations created a vast process of trial and error which, under the grace of God, has brought us to where we stand today.

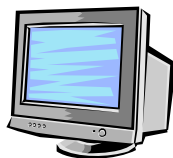

many of these tangled threads unraveled but, little by little, the most broken places of my life straightened out. One day at a time, almost imperceptibly, I healed. Like a thermostat being turned down, my fears diminished. I began to experience moments of contentment. My emotions became less volatile. I am now once again a part of the human family.

Resentment is the "number one" offender. It destroys more alcoholics than anything else. From it stem all forms of spiritual disease, for we have been not only mentally and physically ill, we have been spiritually sick.

As I look at myself practicing the Fourth Step, it is easy to gross over the wrong that I have done, because I can easily see it as a question of "getting even" for a wrong done to me. If I continue to relive my old hurt, it is a resentment and resentment bars the sunlight from my soul. If I continue to relive hurts and hates, I will hurt and hate myself. After years in the dark of resentments, I have found the sunlight. I must let go of resentments; I cannot afford them.

...harboring resentment is infinitely grave. For then we shut ourselves off from the sunlight of the spirit.

It has been said, "Anger is a luxury I cannot afford." Does this suggest I ignore this human emotion? I believe not. Before I learned of the A.A. program, I was a slave to the behavior patterns of alcoholism. I was chained to negativ-

ity, with no hope of cutting loose.

The Steps offered me an alternative. Step Four was the beginning of the end of my bondage. The process of "letting go" started with an inventory. I needed not be frightened, for the previous Steps assured me I was not alone. My Higher Power led me to this door and gave me the gift of choice. Today I can choose to open the door to freedom and rejoice in the sunlight of the Steps, as they cleanse the spirit within me.

God, direct our thinking, that it be divorced from self-pity, dishonest or self-seeking motives. We ask for inspiration that we be shown all through the day what our next step is to be. Give us freedom from self-will. "Thy will be done."

When said sincerely, this prayer teaches me to be truly unselfish and humble, for even in doing good deeds I often used to seek approval and glory for myself. By examining my motives in all that I do, I can be of service to God and others, helping them do what they want to do. When I put God in charge of my thinking, much needless worry is eliminated and I believe He guides me throughout the day. When I eliminate thoughts of self-pity, dishonesty and self-centeredness as soon as they enter my mind, I find peace with God, my neighbor and myself.

District 15 News: April

Twenty-eight people met on march 20th at Community Congregational Church in New Port Richey, for the District's monthly meeting. Treasurer Bob's report reflected that eight groups donated a total of \$411.00. Your generosity is much appreciated. Expenses were up somewhat for February as a result of expenditures that need to be paid on an annual basis. These expenses included such items as \$300.00 annual rent for the District's Archives, \$160.00 for the Anniversary Dinner Dance, and \$26.00 for the District's post office box. Total expenses amounted to \$1990.14. \$449.00 in contributions were received. The beginning balance for the month was \$390.81. The closing balance was \$2363.67

The standing Committee Chairpersons reported a significant amount of activity in the District. Rick, from Archives advised us that the District's Archival presentation at the Anniversary Dinner Dance was well received. Also, Archives will be initiating an inventory of material stored at the Central Office. Virginia, Chairperson of the Treatment Committee, indicated the meetings at ACTS are proceeding nicely. However, there is a recent need for additional volunteers as several 'snow birds' volunteers have gone back home for the summer. If you have time for this worthy service to bring the message of A.A. into treatment centers, please contact Virginia.

Jean, from the Grapevine Committee reports the Founder's Day Celebration is now scheduled for Saturday, June 9, 2007, at the Community Congregational Church, 12 noon to 4:PM. The planned theme will be entitled "Old Timer's Corner." More details will be forthcoming. Chairperson J.D., of Corrections states the Tuesday and Thursday meetings at the Little Road jail are still being filled to capacity. These

are all male meetings. In reference to A.A. meetings being brought to women inmates, J.D. reported the following. Pasco County housed female inmates at the Land-O-Lakes facility. This facility is located within the geographic boundaries of District 2 which provides volunteers for these A.A. meetings. During the course of GSR sharing, it was noted that over 200 individuals attended last month's 4th Step Workshop.

Chairperson-elect Kevin Mc. Advised that dates have already been secured for several of the District's annual special events. The Gratitude Dinner is set for November 18, 2007. Next year's Anniversary Dinner is slated for February 9, 2008. Other details on these and other affairs will be provided as the dates draw closer. Anniversary Dinner Chairperson, Kathy, indicated that a somewhat smaller than expected crowd attended this year's Dinner. Nevertheless, all attendees were well fed and had a great time. Thank you Kathy for providing your services to this event. Chairperson Doug advised the group of ongoing vacancies for alternate Chairpersons in Sub-District 2, 3, and 4.

Under new business, the possibility of the District purchasing a lap-top computer for secretarial needs was discussed. This computer would be utilized for purposes of record keeping, recording minutes, and generating other documentation such as correspondence. The initial investigation for cost suggested a figure of \$350.00 to \$400.00. Suggestions to minimize this cost were also reviewed. At the conclusion of the discussion, it was decided that the issue should be taken back to our groups for further evaluation and consideration. The matter will again be taken up at next month's GSR meeting, which is scheduled for April 17th. As always, your presence is more that welcome. Thanks.
