**Step 5: Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.**

"To another human being?" Wow, that's scary and impossible! That's how I felt when reading Step Five. "To another human being?" Wow, if I did that, all of AA would sweep me out the door along with the dust. My secret closet had lots of terrible things in it.

I would have to admit certain defects and ascertain in a rough way what the trouble is. This requires action on my part, which, when completed, will mean that I have admitted to God, to myself, and "to another human being," the exact nature of my defects. How frightening. This brings me to the Fifth Step in the program of recovery.

I finally did it. Step Five, and guess what? My sponsor didn't hate me, but she kept all my secrets to herself. Another surprise! She

**Tradition 5: Each group has but one primary purpose to carry its message to the alcoholic who still suffers.**

In reading the Tradition from the 12 and 12 the very first line says, "Shoemaker, stick to thy last." What this means to me is that our purpose in the meetings is to talk about alcohol and to carry this message to the still suffering alcoholic. What does my group do to help the still suffering? This is a question that comes up a lot and I can say without a doubt that my group does everything they possibly can to help.

We have three people that volunteer at the Central Office answering the phone lines and being available to sell literature. We have three people who hold offices at District. Twice a month we take a meeting to Detox. There are two people who hold offices with Intergroup trying to make sure that when someone calls the hotline, the hand of A.A. will always be there.

At our meetings when we talk about alcohol and go in depth over the steps of recovery, that is all

gave me a medallion that said, "A.A. and all it's Steps are here to make me feel good". Wow again. All these Steps looked terrifying to me, especially Step Five. At first I gulped in fear, but did Step Five with my sponsor and lot's of apprehension.

And what relief! When it was finished I felt like a complete new life poured into me. No more need I be afraid. Step Five was DONE!!! I had camped out on the Fourth and Fifth Step long enough. I was "working on it." If anyone ever asked where I was in the Steps I'd reply "I'm working Step Four," "or I'm working on Step Five." Working on getting ready to do them was the truth..... Sort of like wanting to want to stop drinking. "I'll put it off until tomorrow."

What am I likely to receive from Step Five? For one thing, I'll get rid of that terrible sense of isolation I always had.

Suffering from those feelings that I never quite belong.

After I did my Fifth Step, my sponsor suggested I begin doing Step Six! "Moving forward is what it's all about," she said.

An old-timer told me "it's either you grow or you go". Such profundity from a group of drunks! "I had to surrender," they said. After you've been through the Steps, then you pass it on! We each share our own experience, strength, and hope with each other.

All the Steps are necessary on the road to recovery. The Promises tell us we'll not regret the past nor wish to shut the door on it We'll see how our own personal experience can benefit others. Others means "to another human being"!!! Imagine that!

## OUR PRIMARY PURPOSE

we talk about. We tell how it was, what has happened, and what it is like right now. And how the steps have changed our lives. We don't get into any of the other addictions or personal problems outside of A.A.. The first thing we do at our meeting is, we read our Statement of purpose given to us from the 1987 General Service Conference which for our meeting says, "This is a closed meeting of Alcoholics Anonymous. In support of A.A.'s singleness of purpose, attendance at closed meetings is limited to persons who have a desire to stop drinking. If you think you have a problem with alcohol, you are welcome to attend this meeting. We ask that when discussing our problems, we confine ourselves to those problems as they relate to alcoholism." The preface to the statement says, "This group strongly adheres to the following statement." There is another statement for open meetings that states; This is an open meeting of

Alcoholics Anonymous. We are glad you are all here—especially newcomers. In keeping with our singleness of purpose and our Third Tradition which states that "The only requirement for A.A. membership is a desire to stop drinking," we ask that all who participate confine their discussion to their problems with alcohol." We try to make it clear from the very start that we deal with alcohol and only alcohol.

The Traditions are here to keep A.A. strong. They came about by our 'founders' and the mistakes they made. They keep us United and doesn't dilute A.A. with other things. My group lives up to this TRADITION and sticks with alcohol problems with alcohol, and the still suffering alcoholic and nothing more.

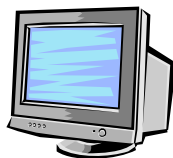

# District 15 News: May

The District held its most recent meeting on April 17th at the Community Congregational Church in New Port Richey. 30 people were in attendance. Treasure Bob advised us of the District's opening balance for March was \$2363.67. The closing balance was \$3722.28. Expenses and contributions were high this month. Primary in reference to donations and cost associated with the Anniversary Dinner. Expenses totaled \$1340.39 and contributions amounted to \$2699. During the month of March, donations were received from five groups. The generosity is gratefully appreciated.

Committee Chairs had some recent developments to report. Rick, Archives Chair, was able to attend the Area 15 Quarterly Meeting in St. Petersburg during the second weekend in April. As a result, our District is registered with Area 15 as having an active Archives Committee. Also Rick stated that the Archives Seminar provided information on appropriate methodologies on how to maintain and expand a District's archives. J.D. the Corrections Chair, attended the Quarterly Meeting as well. He indicated that he was able to meet with the Correction Chair from District 2. Primarily, District 2 covers East Pasco and Hillsborough County. Within District 2 is the Land O' Lakes Correctional Facility which houses the female inmates from all of Pasco County. In conjunction with Rick's meeting with the District 2 Rep, an opportunity now exist for the possibility of volunteers from our District 15 being able to bring meetings to Pasco County correctional females inmates. Future developments will be reported as they develop. Chairperson Doug G. indicated that our District had a total of 10 attendees at the April Area 15 Quarterly. Nancy, District Committee member for Sub-District 2, indicated attendance was down somewhat at the groups within her Sub-District. However,

she attributed this reduction to "snow birds" returning to their homes in the north. Also, Nancy provided a reminder for interested parties to register for the State Convention to be held this summer in Orlando. Available space is being filled quickly.

Under new business, a spirited debate ensued over the possibility of the District purchasing a lap-top computer for the District's Secretary. All District Secretaries do need a word processor of some sort for District meeting minutes, correspondence, Quarterly Meetings and other projects involving the generating and dispersing of information. During the course of the recent Area 15 Quarterly Meeting, it was learned that most Districts have purchased lap-top computers for their respective Secretaries. The larger District's own several lap-tops. One of our members, generously offered to donate a home computer for the District Secretary. However, the big advantage to a lap-top computer is portability. The detrimental side to this type of purchase is cost. Presently, the District does have an opportunity of purchasing a rebuilt lap-top computer for approximately \$200. Also, one of the other Districts within Area 15 offered to donate one of their lap-top computers to our District. Chairperson Doug G. sought and received a motion for those in attendance to go back to their groups and ask for the groups opinion on the nature of purchasing a lap-top computer. Projected cost was capped at no more than \$250. Pending receipt of this information from our District groups. A decision on such a purchase was deferred until next month's meeting which is set for May 15th. The meeting begins at 6:30 pm and is held in Andrus Hall, in the rear of the Community Congregational Church, 6533 Circle Blvd., New Port Richey. If your schedule permits, please stop by and join us.
